

LIFETIME LIMITED WARRANTY **Consoles & Specialized Furniture**

SPECIALIZED FURNITURE S.L. ensures that all its consoles and technical furniture is free from defects at the time of delivery.

SPECIALIZED FURNITURE S.L. offers a LIFETIME warranty unless otherwise specified, from the date of delivery of all non-moving metal components.

SPECIALIZED FURNITURE S.L. warrants the plastic frames, wheels, wood pieces and / or other materials and machinery for two years.

SPECIALIZED FURNITURE S.L., reserves the sole and exclusive right to repair, correct or replace, at its option, any piece of its consoles or technical furniture that in our inspection is declared defective in material or assembly.

SPECIALIZED FURNITURE S.L. warranty will be not applied to damage caused by accident, abuse, neglect, abnormal use or use in extreme climatic conditions. It is defined as normal weather conditions those temperature and humidity that ensure the human comfort and health. Due to the inherent nature of certain materials used, all items containing wood and / or other materials are subjected to minor variations or irregularities of color, grain, and texture.

Compliance with laws, regular codes, certificates and manufacturing standards do not apply if the product has been misused, poorly installed or tampered with in any respect (including without limitation, any change in the mechanical components that affect the stability, carrying capacity or load distribution) after shipment from the manufacturer.

All defective products must be returned to SPECIALIZED FURNITURE S.L., and the customer is responsible for all shipping costs and delivery insurance. SPECIALIZED FURNITURE S.L. will forward the repaired products bearing the expenses. In any case SPECIALIZED FURNITURE S.L. shall be liable for costs or expenses related for dismantling of any defective product of the installation neither any repair nor replacement of the product not supplied by SPECIALIZED FURNITURE S.L. This warranty does not cover damage due to external causes, including accidents, misuse, and problems with electrical power, improper use or installation of parts other than their home SPECIALIZED FURNITURE S.L., which are not under control or address of SPECIALIZED FURNITURE S.L., alteration, storage and / or poor maintenance or careless use. Furthermore, this warranty does not cover damage caused during transport and handling (unless they were in control of SPECIALIZED FURNITURE S.L.) or effects of normal wear.

This warranty does not cover items that are in one or more of the following categories: electrical, software and accessories, or any other part not manufactured by SPECIALIZED FURNITURE S.L. added at SPECIALIZED FURNITURE S.L. product.

In any case, SPECIALIZED FURNITURE S.L. would have responsibility over the purchase price of the product purchased.
